SIM is an Innu organization operating several staffed facilities in Sheshatshiu that care for a number of Innu children and youth in care within provincial child protection services. Ms. Bellefleur is the daughter of Rose Gregoire, an Innu leader in social services who passed away a number of years ago. Ms. Bellefleur will provide background on her mother, including her engagement in the community, providing context for her mother's comments to the Royal Commission on Aboriginal Peoples.
