WHEREAS the parties entered into a CANADA/NEWFOUNDLAND AND LABRADOR CHILD & FAMILY SERVICES AGREEMENT dated the **13<sup>th</sup> day of December, 2004**, ("the Agreement");

AND WHEREAS the Agreement makes provision for adjustments in the amount of funding to be transferred to the Province by the Minister upon notice by the Minister;

NOW THEREFORE, the Minister hereby gives notice as follows:

- 1.0 In accordance with Part C - Section 2.4 and Part F of the Agreement, but subject to the provisions of the Agreement, the Minister will reduce funding for Fiscal Year **2004-2005**, in an amount of up to **one million, five hundred thousand dollars (\$1,500,000.00)**.
