AGREEMENT NO.: 2004 - 2005 - 02 - 00 - 09186 - 0007

WHEREAS the parties entered into a CANADA/NEWFOUNDLAND AND LABRADOR CHILD & FAMILY SERVICES AGREEMENT dated the 13th day of December, 2004, ("the Agreement");

AND WHEREAS the Agreement makes provision for adjustments in the amount of funding to be transferred to the Province by the Minister upon notice by the Minister;

NOW THEREFORE, the Minister hereby gives notice as follows:

- 1.0 In accordance with Part C - Section 2.4 and Part F of the Agreement, but subject to the provisions of the Agreement, the Minister will reduce/increase funding for Fiscal Year 2004-2005, in an amount of up to **eight hundred forty-two thousand dollars (\$842,000.00)**.
